

HOME-BASED EDUCATION

Background

The Division recognizes the legal right of parents to educate their children at home, subject to the provisions of the Education Act.

Procedures

1. The Director or designate must comply with provincial regulations for home-based education.
2. The Director or designate may conduct orientation meetings with home-based educators to assist them with informed decision making about home-based and school-based education.
3. The Director or designate may, if requested by the home-based educator, provide materials, information, equipment, standardized/specialized assessment services, and access to facilities and selected curricular programs for the purpose of enhancing home-based education programs.
 - 3.1 Home based educators can register anytime during the school year before May 31st.
 - 3.2 Home based education will be provided to a student who has attained the age of six years but has not attained the age of 18 years.
 - 3.3 The Division will provide home-based educators with access to textbooks as available. A refundable caution fee may be requested.
 - 3.4 The Division will provide home-based educators with access to common educational resources, such as libraries provided that they do not interfere with the regular program.
 - 3.5 The Division will enable home-based educators to enroll in face to face or distance learning courses on the same criteria as regular GSSD students. Two courses may be taken by Home Based Education students per academic year; three courses will result in registration at the attendance area GSSD school.
 - 3.6 Home based education students may not challenge a course through the Good Spirit School Division.
 - 3.7 The Division will provide home-based educators with access to Driver Education through the student's attendance boundary school.
 - 3.8 Home-based educators will be provided with a programming allowance of \$300.00 per student upon application that includes supporting documentation (Notice of Intent and an Educational Plan)) and is submitted no later than September 25th to the Director or designate.

- 3.9 Upon request of the home-based educator, the Division will provide any norm referenced &/or standardized assessment services to home based students that are provided to other students attending GSSD Schools. The norm referenced &/or standardized assessment shall occur at a location that is chosen by the division employed Professional Services Provider and is acceptable to the Board of Education. The location must meet the standards for the administration of the assessment.
- 3.10 Upon request of the home-based educator, the Division will provide interpretation of the norm referenced &/or specialized assessment and suggestions for instruction. The interpretation shall occur at a location that is chosen by the-division employed Professional Service Provider and is acceptable to the Board of Education.
- 3.11 Upon request of the home-based educator, the Division may consider providing direct therapeutic services by a division employed Professional Service Provider in the event that such services had been provided to the home-based student within the Good Spirit School Division by a division employed Professional Service Provider. The direct therapy services shall occur at a location that is chosen by the division employed Professional Service Provider and is acceptable to the Board of Education.
- 3.12 Extra-curricular programming is available to home-based educators at the attendance boundary school upon discretion of the school administrator.
